DAN PITTMAN REPORTS THE *OHCC WETLANDS HABITAT PROJECT STARTS *- OHCC's project to enhance the habitat for Hellman's Hollow (200 acre property north of Packer Creek) has been activated. The project has an approved Federal Wetlands Program (WRP) Grant from which OHCC will be reimbursed for the cost. The project scope of work includes construction of a new approximate 5,000 foot long dike along the north side of the existing canal located at the south end of the property extended to the east property line then north along the east property line. The new dike will allow control of rainfall to provide up to approximate 40 acres of shallow ponds for waterfowl and other wetland species. Three waterfowl nesting islands and seven small shallow water ponds will be added in areas of the property to improve ponding of water where the natural elevations already collect water during rain events. The construction contract has been issued to Buehler Excavating, LTD, a local Oak Harbor contractor that completed the Packer Creek Dike Project three years ago. Weather permitting, we hope to complete the work before the end of 2009. *For safety reasons, during periods when the contractor has personnel working on the property, the Hellman's Hollow property will be closed to hunters. *For questions, contact Dan Pittman, OHCC's Project Manager, at (419) 862-2759.
