October Meetings

Trustees meeting: President Rudes announced that those members who had previously been grandfathered with special dues, that policy is still in effect for those people only, and their renewal dues are \$75. Those members write "grandfathered" on their renewal and send it in with the \$75. The club had a table at the Apple Festival and talked with numerous people about the club and it's programs. Three new members were signed up. Terry Warner and Terry Rudes maned the table Saturday and Sunday. The club also had a float in the paraded and passed out club information and candy and the float was at the Fire Station after the parade where people could by tickets for the drawing on the float.

The Hunter Education classes held at the Darr were very well attended with some 22 people attending.

Chuck Yarletts reported on the Rimfire Sporter Matches held at the club this year so far included shooters from Pennsylvania, Indiana, and a club of shooters from Michigan. The matches are CMP sanctioned matches and scores can be found on the CMP webpage. Several of the OHCC junior and adult members have earned medals at the local matches as well as in competing at the National Matches at Camp Perry this summer. The trustees also approved dates for the monthly sporter matches for next year and a training clinic for Reveres Riders on January 10.

Joe Heim posed a question regarding constitutional amendments and informing the membership. Joe, being a former trustee, believed that there was a 3 reading rule for constitutional changes.
