Don Hunter called for membership to vote on approving T&O motion to fund \$5,000.00 to go with the DNR funds, motion passed unanimously.

Scott Storer asked does reserve funds come from and where is the \$100 capital improvement dues going. Terry Rudes replied \$100 goes into Capital Improvement. Terry went on to say budget committee allocated funds by income, allocated it the Darr and Gordon Rd. C-4. Monies not spent carry over. The Finance committee is the President, VP, Tresurer, Secretary and Terry Warner appointed.

New Business:
