**New Business:** Terry Rudes spoke of fund raising and shifting the budget to cover expenses. We could convert the club to a C-3 to reduce property tax by about \$6,000.00 annually. Accountant Victor Ken-Brink could see about whether to transfer the property to the new C-3.
